POSITION SUMMARY

Under general supervision, plans, schedules and supervises work crews performing sign fabrication and maintenance, pavement striping, installation and repair of traffic signs and control devices, and providing traffic control at job sites. Supervises and inspects projects and special assignments to assure work quality and timely accomplishment of assigned duties and responsibilities; coordinates a variety of administrative activities, including employee scheduling, payroll reporting and report processing; orders materials and supplies inventory; prepares daily activity and material usage reports; responds to emergencies and coordinate county resources according to plans and needs; dispatches and accounts for crew activity during emergency events.
