This position is responsible for investigation and surveillance of reportable communicable diseases including tuberculosis, hepatitis C, and sexually transmitted infections. The Public Health Nurse provides disease investigation, surveillance, health education and counseling services to support the prevention, treatment and control of diseases, and the promotion of optimal health. This position also supports with outreach efforts by assisting in creating content for informational materials and by building and maintaining relationships with healthcare providers and other community partners.
