## **DEPARTMENT / OFFICE**

This position reports to the Public Works Deputy Director and is in the Lewis County Public Works Department, located in the Public Services building at 2025 NE Kresky Ave, Chehalis, WA.

## **POSITION SUMMARY**

Under limited supervision, performs professional work of considerable difficulty in managing and coordinating design, engineering, development, flood control, stormwater drainage, river management, bridges, utilities, and infrastructure projects for the Public Works Department (PWD). This position may may have direct and indirect reports.

The Utility Services Division is responsible for establishing, operating, and maintaining public systems for the supply, treatment, and distribution of water and for the collection and treatment of wastewater and stormwater. The Utility division coordinates closely with the Engineering Services' surface water engineer. Currently, Utility Services manages and operates the Vader - Enchanted Valley Water System and the Middle Fork Water and Sewer System.

This position is covered by a collective bargaining agreement between Lewis County and Teamsters 252. New employees must successfully complete a six (6) consecutive-month probationary period prior to obtaining permanent status in this classification.
