POSITION SUMMARY

Under close supervision, assists with maintaining and repairing traffic control signs and components. Conducts traffic control such as flagging, placement of temporary signing and other warning devices, assembles and erects traffic control signing devices, and assists with striping of roadways and pavement markings under the authority and direction of the Traffic Control Supervisor. This position is considered essential when an emergency occurs and can be called by supervisory or emergency personnel as needed.
