# **DEPARTMENT / OFFICE**

This exempt position reports to the Public Works Deputy Director and is in the Lewis County Public Works Department, located in the Public Services building at 57 W. Main St, Chehalis, WA.

#### **POSITION SUMMARY**

Under limited supervision, manages and administers the activities and operations and personnel assigned to the Water, Sewer, and Stormwater utilities in the Utility Services Division within the Lewis County Public Works Department. This position develops, oversees, and reviews plans and programs associated with the County's water, sewer, and stormwater infrastructure and the flood control zone districts the County services. Provides oversight, technical support, and implementation of the local and state issued stormwater requirements.

The Utility Services Division is responsible for establishing, operating, and maintaining public systems for the supply, treatment, and distribution of water and for the collection and treatment of wastewater and stormwater. Currently, Utility Services manages and operates the Vader - Enchanted Valley Water System and the Middle Fork Water and Sewer System.

New employees must successfully complete a six (6) consecutive-month probationary period prior to obtaining permanent status in this classification.
